## **Ways to Give to the Peace Haven Baptist Church of Winston-Salem Endowment**

### **CASH**

Gifts of cash, usually in the form of a check, are an easy and convenient way to support the Peace Haven Baptist Church of Winston-Salem Endowment.

### **SECURITIES**

Gifts of appreciated securities may be used to support the Peace Haven Baptist Church of Winston-Salem Endowment. Following transfer of securities to a Foundation account, liquidation and payment of broker's fees, the net proceeds are available to support the Endowment. Accepted gifts include - publicly traded stock,

closely held stock, restricted stock, partnership interests (including family limited partnerships), and mutual funds. Be sure to notify The Winston-Salem Foundation of your impending stock transfer.

### **REAL ESTATE**

You may wish to consider naming The Winston-Salem Foundation as the beneficiary of a gift of real estate – such as the gift of a house or other personal residence, farm, commercial building, or undeveloped land. Peace Haven Baptist Church of Winston-Salem will the approval of the Winston-Salem Foundation’s willingness to accept the gift.

### **PERSONAL PROPERTY**

You may contribute to the Endowment with gifts of personal property, such as artwork and jewelry. After expenses and the liquidation of the personal property, the net proceeds are available to support the Endowment

### **BEQUESTS**

You may name the Endowment in your Will or Living Trust. A charitable bequest can be a specific dollar amount, a percentage of your estate, or what remains after other bequests are made. For example, your Will might simply state: “After all my bills are paid, I want 10% of my estate to go to The Winston-Salem Foundation for the Peace Haven Baptist Church of Winston-Salem Endowment.”

### **RETIREMENT PLAN ASSETS**

Retirement plan assets are an excellent way to give because they are so heavily taxed if left to heirs. People who have planned carefully for their retirement may find that the assets in their IRAs and other qualified plans exceed their needs. You may designate that assets remaining in the plan after your death are contributed to the Peace Haven Baptist Church of Winston-Salem Endowment.

### **LIFE INSURANCE**

Naming The Winston-Salem Foundation as the beneficiary of an insurance policy is a convenient and effective way to participate and make a contribution to the Endowment. There are two easy ways you can use life insurance to fund your giving. If you have a paid-up (or cash value) life insurance policy that you no longer need for its intended purpose (e.g., your children are grown, your spouse is deceased, or tax laws have changed), you can give the policy to the Winston-Salem Foundation designated for The Peace Haven Baptist Church of Winston-Salem Endowment. Or, you can make life insurance part of your estate planning by naming the Foundation as a beneficiary of any insurance policy's death benefit and specify that you want the proceeds to be added to the Peace Haven Baptist Church of Winston-Salem Endowment.
